1 Schedule of Changes

- 1.1 The schedule below lists changes to the adopted Telford & Wrekin Local Plan Polices Map as a result of the Local Plan review (Regulation 19 version). The changes have been carried out due to:
- Consequential changes to existing Local Plan policies; and
- Changes as a result of the inclusion of new policies requiring land designations.
- **1.2** Further changes to the Policies Map have been identified following the Regulation 18 draft plan consultation and these are reflected in the schedule below.
- **1.3** Table 1 below summarises the proposed changes to the policies map.

Housing Sites	Layer showing allocated housing sites	Housing sites had been shown as proposed allocations in the draft local plan policies map.		
Employment Sites	Layer showing allocated employment sites	Employment sites had been shown as proposed allocations in the draft local plan policies map.		
Mixed Use Sites	Layer showing allocated mixed use sites	Sites have been proposed in Telford Town Centre as potential allocations. The Telford Town Centre area supports main town centre uses – mixed uses have been proposed recognising the potential for residential led regeneration. Additional mixed use sites have been identified at Mere Park (site MU8) – this is a mixed commercial site and land at Wheat Leasows (site MU9) – as a consequence of re-aligning the boundary for the Strategic Employment Area (SEA) the site is now remote from the employment zone allowing for consideration of a broader range of uses.		
Sustainable Communities	Layer showing Sustainable Communities sites	The Council have identified 3x potential Sustainable Communities (previously titled Sustainable Urban Extensions) sites.

'Housing sites carried forward' and 'Employment carried forward'	Housing and employment allocations carried forward from the Telford & Wrekin Local Plan 2011-31. Removal of employment designation from employment site E18.	These are housing and employment sites adopted in the Telford & Wrekin Local Plan 2011 – 2031 that will be carried forward (remain as allocations) in the new Local Plan. The removal of the SEA designation from Telford Town Centre at the draft plan stage has created an outlying portion of the Central Telford SEA. The removal this outlying portion of the SEA justifies the removal of employment site status from site E18. This land will now be shown as white land on the Policy Map.		
Neighbourhood Development Plan (NDP)	The inclusion on the Policy Map of parish areas where Neighbourhood Development Plans (NDP) have been made.	Neighbourhood Development Plans form part of the overall development plan for the borough.		
Local Centres	Additional Local Centre designation at Dale End.	Dale End has been identified as a proposed local centre due to the concentration of commercial activity in the area and the day to day shopping facilities. The location of future local centres contained within the Sustainable Communities sites have not yet been identified. However, subject to planning, those centres will then be protected by Local Plan policy EC8.		
Rural Settlements	Additional Key settlements at Allscott and Crudgington.	Additional key rural settlements have been identified due to existing levels of development, available services and facilities and potential suitability for housing allocations. Rodington has been removed from the list of key settlements included within the draft Local Plan and is no longer identified as key settlement in the Local Plan.		
Built up areas (Telford)	Amended built up area boundary to include sites adjacent to the edge of Telford including; Boundary adjustments on Dawley Rd / A5223 south of M54 Boundary adjustments along M54 east of Junction 7	There has been development at Redhill/A5 which has extended the built urban form out to Woodhouse Lane. Other adjustments recognise that allocated sites adjacent on the edge of Telford will now form a part of the urban area.
