

We have studied hard the plan you propose for the 2,000 houses by the Old gate Pub & we oppose it in every way possible-

The infrastructure is not good enough, there is no need to build that many houses when there is brown belt land available. Green belt land should stay green belt, the amount of people opposing this should be taken into consideration - the proposal should be scrapped or the size significantly reduced to keep it in line with the country look.

Reasons for opposing-

It floods on those fields all the way down past the gate pub, and has done for years, this will in turn cause insurance on the houses you intend to build to be more expensive and difficult to secure.

health services: Shawbirch medical Practice is already over run, the full emergency A&E is moving to Shrewsbury which is a complete disaster with how quickly the Telford housing population is increasing. Just no care for people-how are all these new people going to access health care services? Take nhs dentistry - it's virtually impossible now to get a dentist, and if you do often you're travelling miles to get seen. Have you considered the health needs of all these new residents?

The plans state you will create green spaces-leave the green spaces alone they are already green! That area is already teeming with wildlife, natural habitats a beauty spot for Telford. people from all around come to walk to see the scenery particularly the Wrekin soon when you go to the top of the Wrekin & look down all you will see is houses not farms & fields. The natural scenery people so love to visit will be gone.

2,000 houses around on average 4 in each home say 8,000 people probably more - what about the police station the small one we have in Wellington is under staffed as it is at the minute, more people more crime. Houses are not affordable -they said they were going to be affordable in Allscott Meads but they are most definitely not-there's a few under £300,000 that is not affordable housing most of them well over £300,000.

We have little faith in the planning process or decisions made by officers and councillors. At Allscott meads, the school should have been built where the now Sports & Social club is, away from the road but because they wanted to save funds they built it on the road...now there are moans about the speed of the traffic so close to the school. it would of been much safer to put the school where the sports & social club was, residents campaigned for this but it was thrown out 7 people objected who didn't even live in the area. This is the problem residents who live in the area should have the say not people who live miles away in Wolverhampton. Its our neighbourhood and community not there's. Safety of the children should always come first!

What about education provision? Charlton is full Allscott meads is full what schools are you intending on building? primary secondary? Where? How many? And how will these children get to school? Will you provide transport?

Its like a cup - its overflowing you keep putting water in and its just coming out the sides absolutely impossible for people to live.

The jobs you are talking about creating are building the houses I suspect when the houses are built if they get built the jobs will be no longer available. Where is the long term employment for these people?

The highways infrastructure cannot handle all these new people and their cars. Being conservative you're probably talking 2000 more cars-just think of the pollution this is not creating greener spaces this is polluting the spaces we have! The roads are not built for this many cars there will be more accidents, more cracks in the roads, which already aren't repaired, the quick route down rushmoor lane which many of these people would use is not even a proper dug out road its just a thin bit of tarmac on top of an old country lane that already has cracks and holes in. It's ridiculous to think this is going to be safe it's a danger waiting to happen. Big artic lorries that come down the lane now can not get past when a car and an artic comes down or two artic it's ridiculous they have already damaged the roads and peoples houses and gardens with the amount of heavy traffic coming down this lane! I have attached evidence that the roads can not cope now so when if you start this project we will be taking legal advice about the state of the road and our houses deteriorating from this project! Again killing the wildlife and adding more pollution.

So on the above grounds we oppose and we probably speak for most of Admaston Shawbirch Rushmoor & surrounding areas. find some where else to build the houses.
