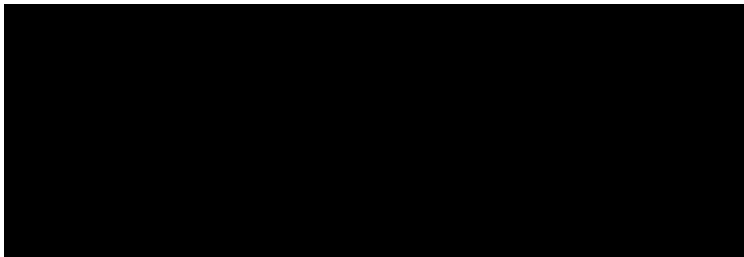

There is just over one week left to have your say on the proposed modifications to the Telford and Wrekin Local Plan.

Telford & Wrekin Council launched a six-week consultation on **Monday 8 June** into modifications recommended by the independent Planning Inspectors, alongside proposed amendments to policy maps and minor revisions to the Plan. The consultation closes on **Monday 20 July**.

The proposed modifications were identified following the Local Plan Examination Hearings earlier this year and have been suggested by the Inspectors to ensure the Plan can be found sound.

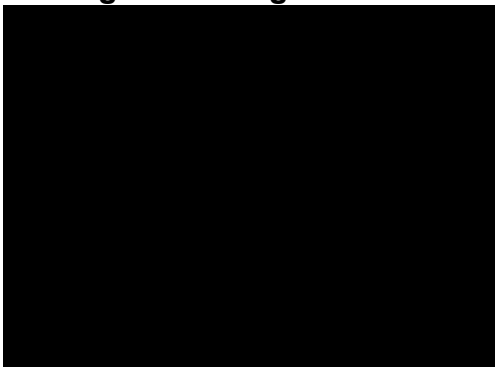
Hard copies of the proposed modifications and documentation are also available at libraries and community centres across the Borough.
